There is no vehicle access to this area so we strongly suggest bringing a cart or two wheel dolly to transport your stuff. We strongly encourage you to set up on Friday night since there will be many other vendors trying to move in and it could get quite congested on Saturday morning. There will be security over night.

We regret that there is no free parking at this event since all vehicle access to the Will Rogers complex is controlled by their parking staff. Parking is \$5 per vehicle on each day.

The festival hours are from 10:30 am to 11:00 pm on Saturday and 11:30 am to 7:30 pm on Sunday.
